SHORT ANSWER

California has nine USCIS field offices: Los Angeles, Santa Ana, San Bernardino, San Diego, Chula Vista, San Francisco, San Jose, Sacramento and Fresno. Immigration courts include three in Los Angeles, plus San Francisco, Concord, Sacramento, San Diego, Santa Ana, Otay Mesa, Imperial and the detained-docket court in Adelanto. USCIS and immigration court offices do not accept walk-ins; always go to the address on your notice. The Turkish Consulate General in Los Angeles is actually in Beverly Hills and serves the entire state.

Biometrics happen at the Application Support Center listed on your notice. Since May 18, 2026, attorneys can no longer join field-office or affirmative-asylum interviews remotely except in limited circumstances.

Türkiye is a member of the Hague Apostille Convention, so no further legalization is needed after the California apostille.
