SHORT ANSWER

Green card and citizenship interviews for the Los Angeles area take place at the USCIS Los Angeles Field Office (300 N. Los Angeles St.); biometrics happen at support centers in La Brea, El Monte, Gardena, San Fernando, Pomona and Bellflower. The USCIS Los Angeles Asylum Office is actually in Tustin, Orange County. The area has three immigration courts. The Turkish Consulate General is actually in Beverly Hills. USCIS offices do not accept walk-ins; always go to the address on your notice.
